Please be aware that as part of your treatment you may need to answer a series of questions which will help the practitioner come to an understanding about your treatment needs. Although rare, some bruising may occur at the site of insertion. Please feel free to ask any questions that you may have. It is important to be on time for your treatments, and to give 24 hours notice if you need to cancel. A fee of \$30 will be charged for missed appointments. Office visits are currently \$110 for the initial treatment, and \$80 for each additional treatment. Payment is due at the time of treatment. The cost of herbs will vary. If you find any of the conditions of treatment difficult to meet, please feel free to ask if arrangements may be made.

Shelly Greene earned her Master of Science in Oriental Medicine degree from the Southwest Acupuncture College in Santa Fe, New Mexico in July 2002. This degree encompasses training and clinical experience in acupuncture, moxibustion, cosmetic acupuncture, cupping, auricular therapy, herbology, tui na (oriental bodywork and alignment), electrical stimulation, and nutritional therapy.

The degree of Master of Science in Oriental Medicine includes 1605.5 actual classroom hours, 1217.5 clinical hours, and an additional 128 elective hours, totaling 2951 actual hours or 170 college credit hours and is a four academic year course of study.

Shelly is certified for both Acupuncture and Chinese Herbology, by the National Commission for the Certification of Acupuncturists. She has never had a license suspended or revoked for any reason.

This practitioner complies with all the rules and regulations promulgated by the Colorado Department of Health including those relating to the proper cleaning and sterilization of needles and the sanitation of acupuncture offices. This practitioner uses only single-use, disposable, factory-sterilized needles for every treatment.
